***Detention***

Benton: 9 youth were held for 80 total of days of care, 1 females and 8 males.  
 Total Admissions to Detention = 9  
 Average Daily Population = 2.67 youth  
 Average Length of Stay = 8.89 days

Linn: 19 youth were held for 100 total of days of care, 6 females and 13 males.  
 Total Admissions to Detention = 22  
 Average Daily Population = 3.33 youth  
 Average Length of Stay = 4.55 days

Lincoln 1 youth were held for 30 total days of care, 0 females and 1 males  
 Total Admissions to Detention = 1  
 Average Daily Population = 1.00 youth  
 Average Length of Stay = 30 days

***Probation***

The Juvenile Department received 55 referrals during the month of 2023.

Of the 55 referrals, 9 represent dependency, 14 status and 31 criminal.

There are currently 190 youth in the Probation Unit either on probation or pending court with 35 of those being assessed high-risk.

There are currently 82 youth under the Community Programs Unit serving on informal probation and the Intervention Specialist is currently serving 101 youth. 95 of those youth are from the community with no involvement with law enforcement.

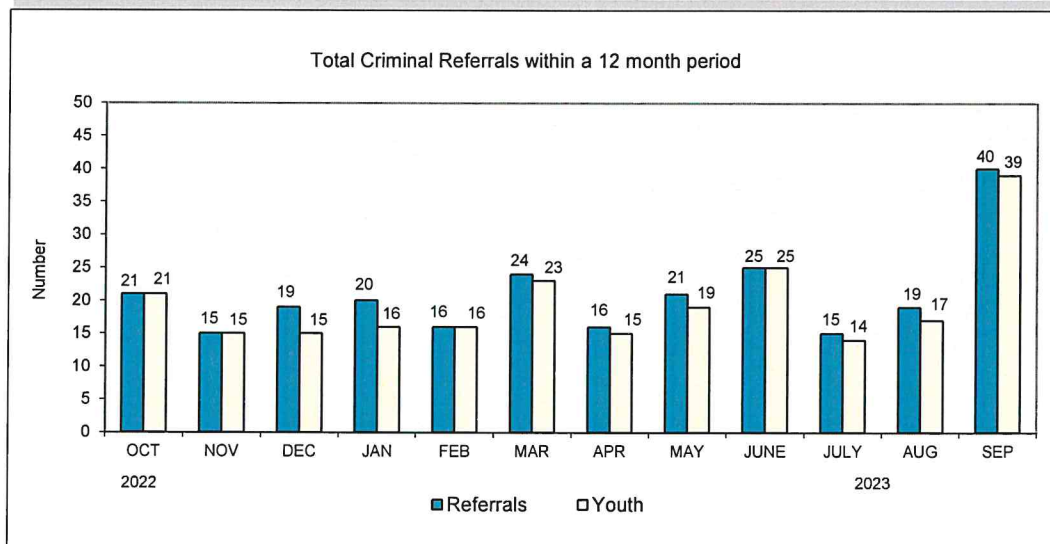

## Resolution and Order 2023-371

### An Intergovernmental Agreement Between the Greater Albany Public School District and Linn County for Education Transition Services

**Contract Amount: \$125,943**

RO 2023-371 is an agreement with GAPS to transfer the Title 1D funds received from the Oregon Department of Education to Linn County Juvenile Department because of the Linn Benton Juvenile Detention Center and the Jackson Street Youth Shelter being located within their school district. Each year during the month of October a count is taken to determine the following year's money award.

GAPS has been a great partner in passing these dollars to the juvenile department to provide an array of services for youth in the detention center and youth shelter. Monies received provide partial funding of the Horticulturist Position at the detention center, the Educational Transition Specialist position at the detention center along with some additional staff for classroom assistance in the detention center. All youth at the detention center benefit from these services not just GAPS youth. Funding is also passed from the juvenile department to Jackson St. Youth Services for tutoring services, summer educational services and transportation services for youth attending public schools from the Albany House.

This is a good example of a fairly small amount of money being stretched to benefit many more youth than could ever be served solely by GAPS if they were to keep the money and hire an individual staff.

## Board Summaries for October 31, 2023

### R&O 2023-378

This is an Intergovernmental Agreement between Greater Albany Public School (GAPS) and Linn County. GAPS and Linn County have partnered to allow GAPS staff to use any office space at the Linn County Health Services buildings to assist with GAPS with student requirements. This agreement has no financial reimbursement requirements.

### R&O 2023-391

This is an agreement between InterCommunity Health Network (IHN-CCO) and Linn County. IHN will be providing Linn County with a grant of \$75,000 to assess the feasibility of a Crisis Receiving Center. This agreement is effective from October 1, 2023 to September 30, 2024.

Vacation proceedings have been initiated by petition of 100% of the abutting landowners of a Public Road, A Street (Shedd) (Public Road 3401-D) in Linn County, Oregon.

As Linn County Roadmaster, I am providing this report as required by ORS 368.346(1), and requested by the Linn County Board of Commissioners.

A map showing the property proposed to be vacated and the ownership of the properties abutting or underlying that portion of the right-of-way proposed to be vacated is attached for your review.

One Hundred Percent (100%) of the owners request vacation of the roadway.

I find that no owner of a recorded property will lose the right of access by this proposed vacation; and further, that the property is not needed for use as a county road to provide access to parcels of other ownership abutting or underlying the roadway to be vacated.

Therefore, it is my opinion that it is in the public interest that the vacated property shall vest in the owners of land abutting the vacated property by extension of the person's abutting boundaries to the center of the vacated property [pursuant to ORS 368.366(1)(d)]

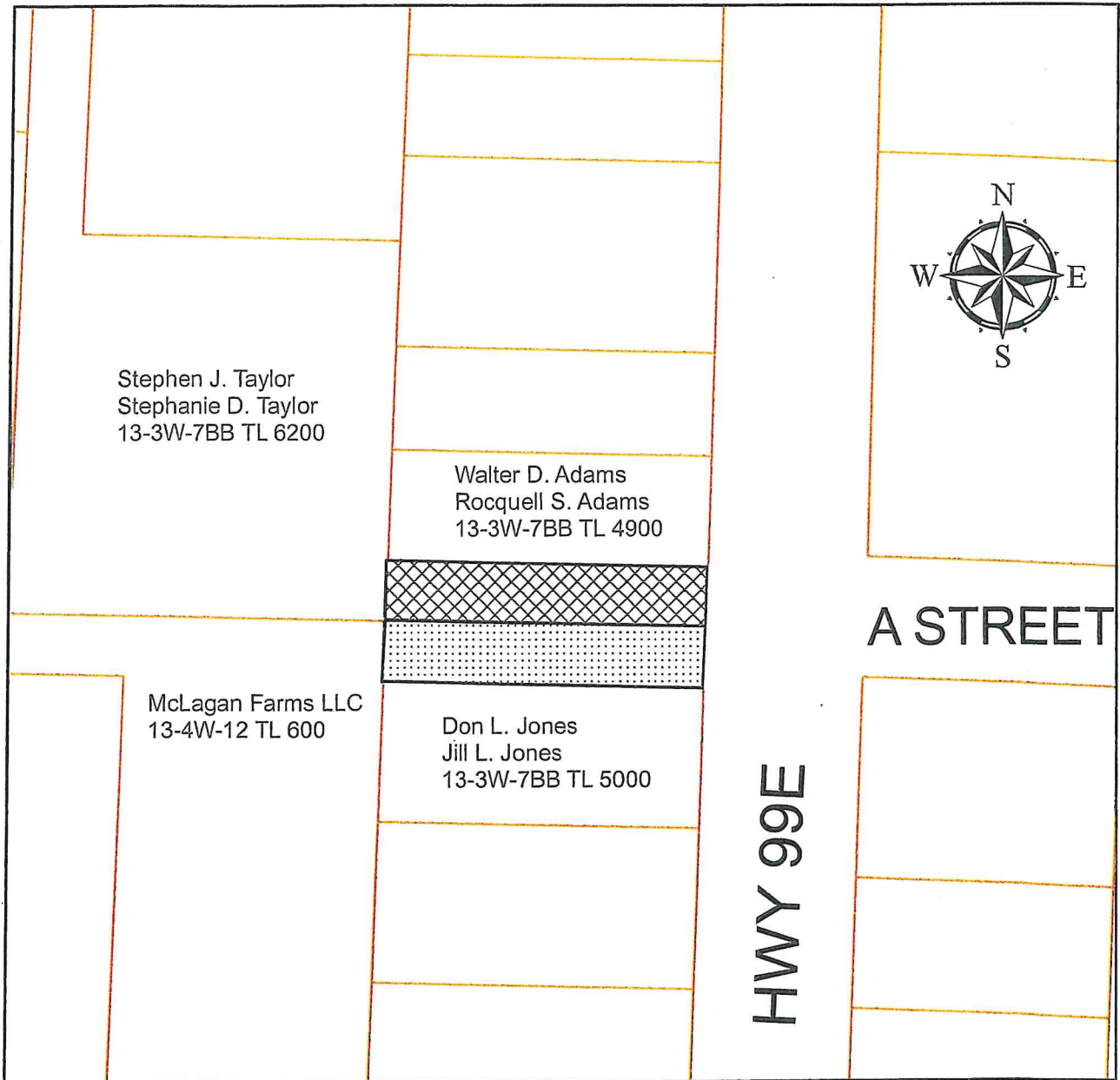

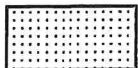
# Vesting of Vacated Right of Way
