Of the 77 referrals, 13 represent dependency, 20 status and 42 criminal.

There are currently 202 youth in the Probation Unit either on probation or pending court with 34 of those being assessed high-risk.

There are currently 101 youth under the Community Programs Unit serving on informal probation and the Intervention Specialist is currently serving 122 youth. 116 of those youth are from the community with no involvement with law enforcement.

Victim Advocate had 81 contacts with victims.

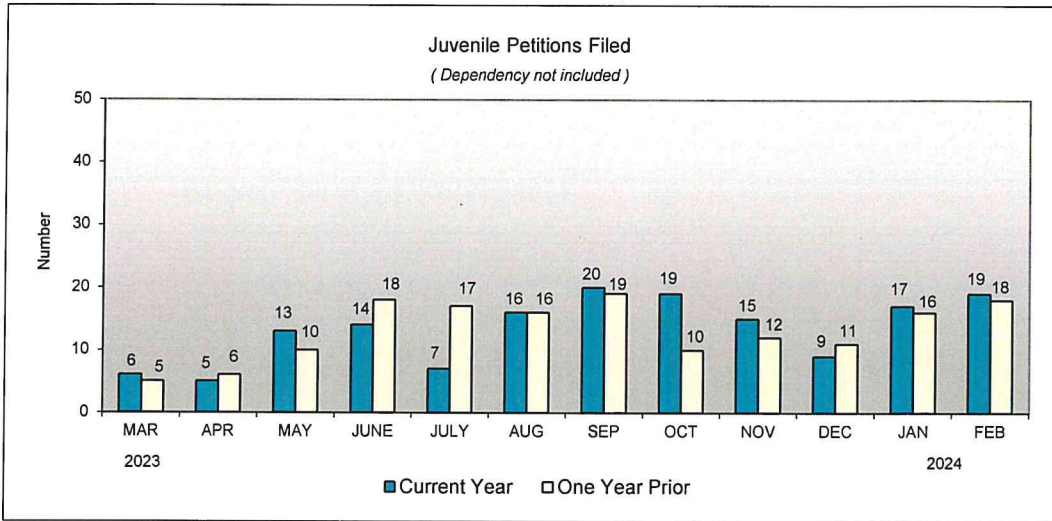

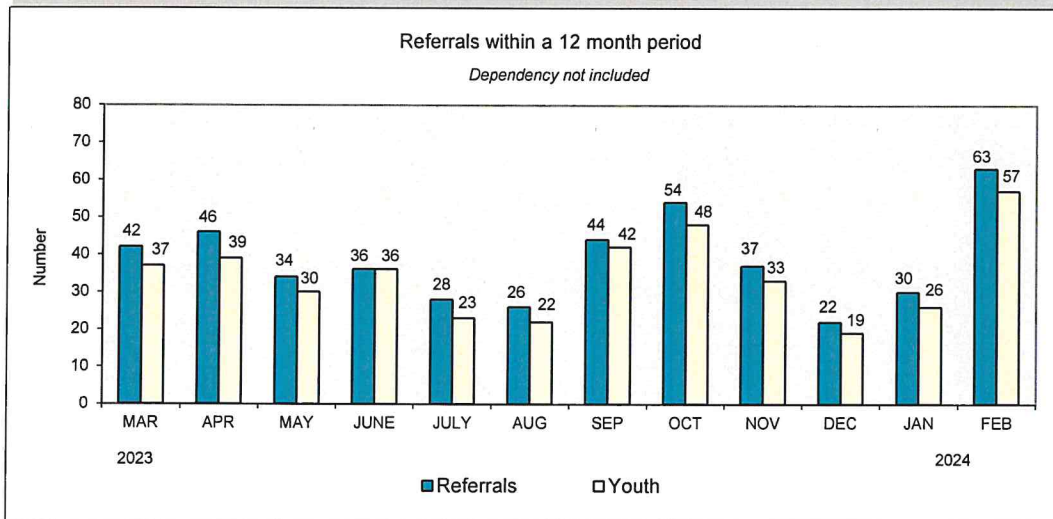

FEBRUARY 2024 Statistics

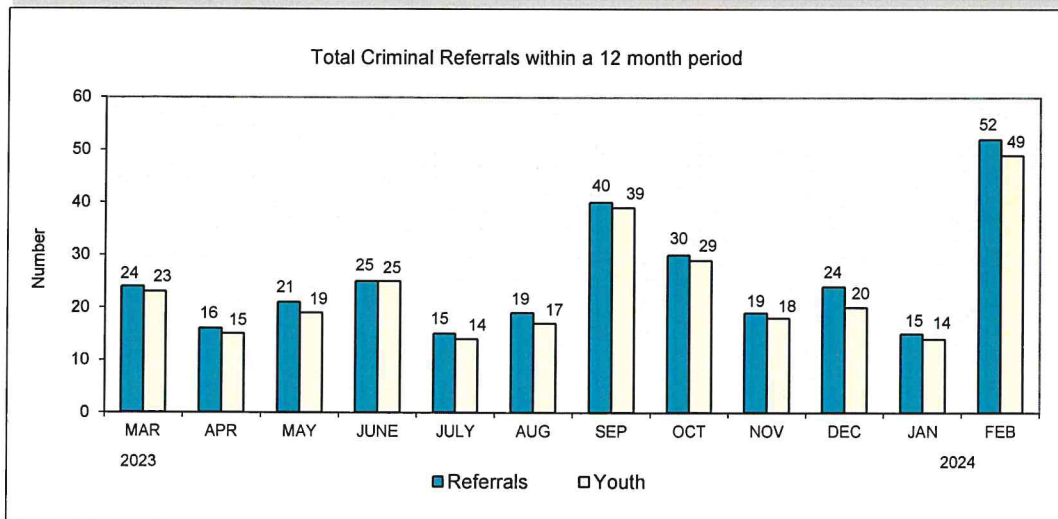

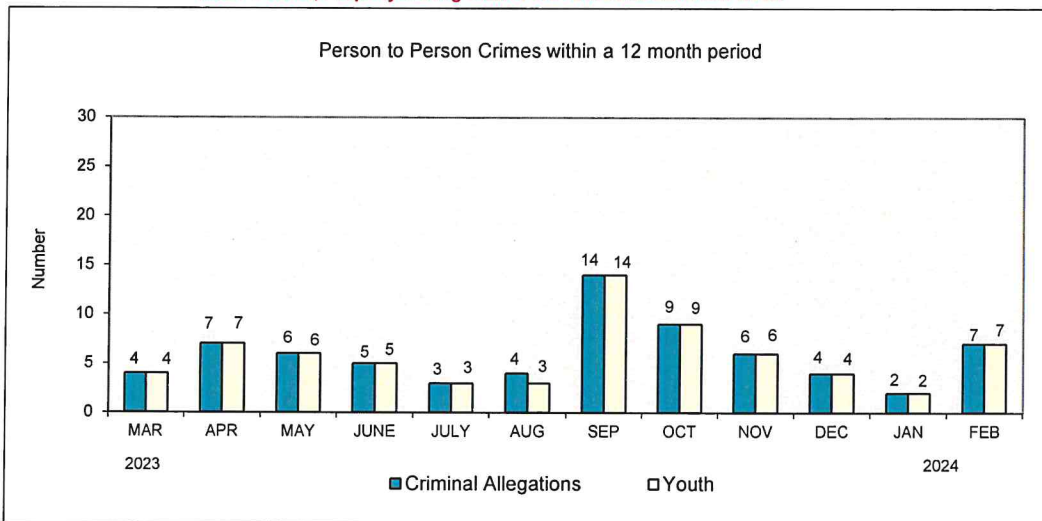

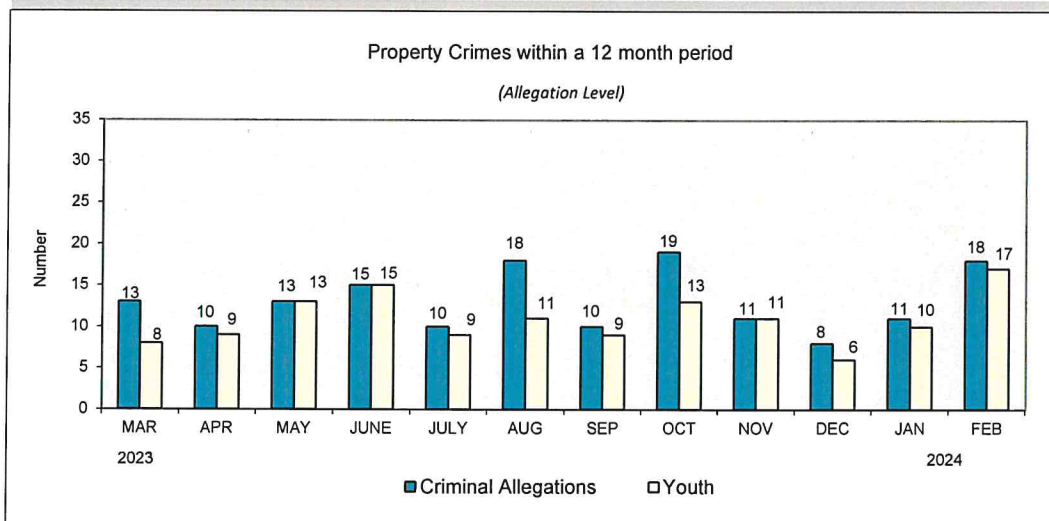

Note: Person, Property & Drug Crimes are at the ALLEGATION level.



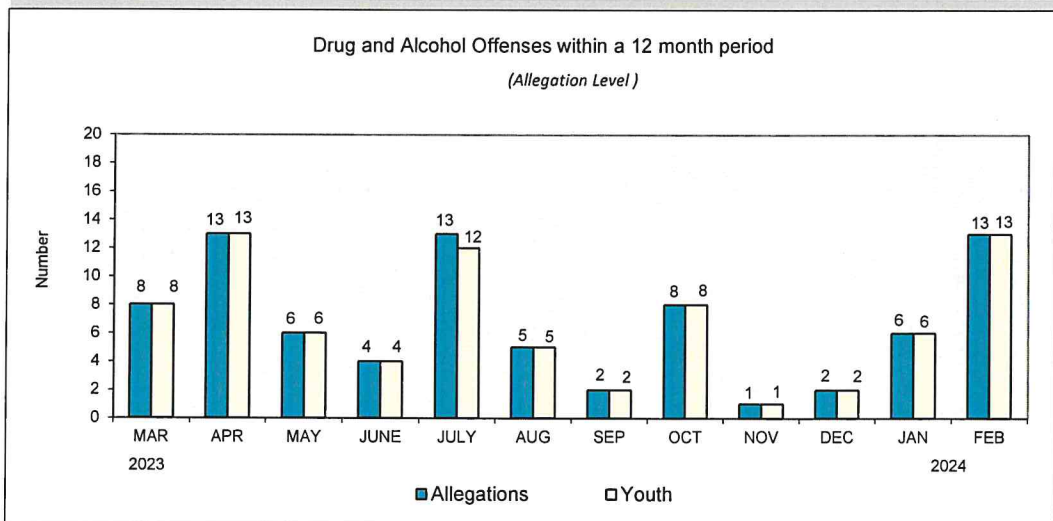

R&O 2024-112 Rural Veterans Healthcare Transportation (RVHT) Grant Agreement with ODOT

Rural Veterans Healthcare Transportation funds are statewide competitive funds awarded to projects in Oregon that meet the specified criteria. Linn County Transportation and Linn County Veterans Services collaborated on an application for funds to bolster the LC Veterans Services department in their existing effort to provide healthcare transportation for Veterans in Linn County. ODOT Grant Agreement 35657 provides up to \$50,000 in funding for contract purchased services supporting veterans seeking healthcare that improves the reach, efficiency, and affordability of public transportation as a service option.

The Linn County Veterans Services have a long history of transportation needs exceeding the available funding. These project funds will allow Linn County Veterans Services to provide more services to rural Veterans during the project period. Linn County will be required to direct the funds towards services that meet the criteria and definitions of the RVHT program.

Linn County Transportation will monitor and provide reporting assistance on the grant as the acting Qualified Entity and primary recipient. Linn County Veterans Services, as the lower level sub-recipient, will deliver the objectives of the project and report to Linn County Transportation.

The following item is scheduled to be signed by the Board on March 26, 2024:

Resolution & Order No. 2024-103: Adoption of the updated Linn County Community Wildfire Protection Plan (2024-2029). The Linn County Community Wildfire Protection Plan (CWPP) is a result of intergovernmental collaboration with local, regional, state and federal partners to identify and reduce wildland fire risk to communities and landscapes in Linn County. The original CWPP was adopted on February 13, 2008 under Resolution & Order 2008-004. The updated CWPP reflects the changes that have occurred to local wildfire response, state and federal laws, and countywide preparedness in last 16 years.

The CWPP is designed to meet federal requirements in the National Fire Plan and the Healthy Forest Restoration Act of 2003. Having an up-to-date CWPP allows local jurisdictions and non-governmental organizations to be eligible for federal wildfire mitigation grants. According to federal rules, the CWPP must be approved by the Linn County Fire Defense Board, the Oregon Department of Forestry, and the Linn County Board of Commissioners. The Linn County Fire Defense Board (represented by Albany Fire Chief Shane Wooton) and Oregon Department of Forestry (represented by Sweet Home Unit Forester Craig Pettinger) have reviewed the CWPP and approved it in advance of the Board meeting.

The CWPP is not a legally binding regulatory document or a scientific report. It brings together the best available risk analysis, local knowledge, and mitigation recommendations to create a plan for local partners to prioritize fuel reduction projects and reduce structural ignitability countywide. By adopting the Plan, the Board does not create any regulations or restrictions on local governments, private citizens or organizations.

The Linn County Emergency Management and the Linn County Planning and Building Department recommend the adoption of the CWPP as presented.
