The grants are available to registered Community-Based Organizations that work in Linn County, Oregon. The initial grant period is through December 22, 2023. If additional funding is received an extension may be posted.

Linn County Health Promotion team (LCHP) is dedicated to empowering individuals and communities “to increase control over, and to improve, their health” (WHO, 2023). We value and promote informed decision-making, dignity for all, and collective responsibility.

### **PURPOSE OF GRANT**

---

The Reproductive Health Education grants are available through Linn County Health Services are to support access of Linn County, Oregon residents to comprehensive, culturally responsible, high quality, and evidence-based reproductive health services with a focus on serving individuals with limited resources and experiencing health disparities. Approaches that integrate inclusive, trauma-informed, and interactive strategies for reproductive health education will be prioritized. Applications are competitive and will be rated according to their organization’s capacity and the submitted scope of work addressing this purpose and subsequent objectives.

### **SCOPE OF WORK**

---

The objectives of this grant are:

- Objective 1: Develop and maintain strategic partnerships with shared accountability to drive a collective impact in support of public health goals relating to reproductive health (RH).
- Objective 2: Identify barriers to access and gaps in RH services in collaboration with community partners.
- Objective 3: Develop and implement strategic plans to address gaps and barriers to accessing RH services in collaboration with community partners.
- Objective 4: Ensure the program integrates strategies and approaches for equity, inclusion, and belonging.

Objective 5: Assess the outcomes of the program plan.

The grantee will be responsible for reporting back regarding the advancement, accomplishment, or need for adjustment of the objectives at the end of the agreed grant period (December 31, 2024). The grantee will also be responsible for financial accountability of funds spent. The programmatic and funding report can be found at the end of this document.
